**All shipments from without the European Community had to arrive at Essen latest 30.08.2022**

There will be a surcharge for all handling fees for shipments arriving at Essen after 05.09.2022 of 25 % - arriving after 08.09.2022 of 50 % and arriving after 12.09.2022 of 100 % .

**For tobacco products from European Countries, we need the details for special permit up to 05.08.2022 latest.**



Import tax and duty had to be paid for all products for Inter Tabac – even if they are samples.

The import tax is 19 % of the CIF value and duty is

Cigarettes	57,6 %	of the value / HS Code: 240220
Cigars	26 %	of the value / HS Code: 240210
Pipe tobacco	16,6 %	of the value / HS Code: 240311
Water pipe tobacco	74,9 %	of the value / HS Code: 240319
Liquids for E-cigarettes	16,6 %	of the value / HS Code: 24041

Please notice that the German Tax Stamps had to be placed on each tobacco package and the outside had to be printed according to the instructions you have already on hand supplied by Westfalenhallen Dortmund.

**We will only accept tobacco shipments with German Tax Stamps and correct labelling of all Health Warnings !!!**
